**1. IMAGES ON CD**

1.1 YOUR CD OF EVENT PHOTOGRAPHS COMES WITH OUR PERMISSION TO PRINT COPIES OF THE IMAGES, FOR USE ONLINE, OR FOR MARKETING OF OUR BUSINESS.

1.2 EXTRA CD'S BEYOND THE TWO FREE COPIES MAY BE PURCHASED BY THE CUSTOMER AT \$5.00 EACH.

**2. DEPOSITS**

2.1 THE CUSTOMER SHALL MAKE A DEPOSIT TO RETAIN THE DATE OF THEIR EVENT. TOTAL COST OF THIS DEPOSIT IS NON-REFUNDABLE.

**3. PAYMENT**

3.1 REMAINING BALANCE MUST BE PAID AT THE BEGINNING OF SET-UP OF THE EVENT.

**4. NEGATIVES AND COPYRIGHTS**

4.1 THE PHOTOBOOTH OWNERS DO NOT HAVE A COPYRIGHT TO ANY PHOTOS TAKEN AT ANY EVENT. CLIENTS AND THEIR GUESTS ARE FREE TO USE THEIR IMAGES AS THEY WISH.

4.2 THE PHOTOBOOTH OWNERS DO NOT KEEP COPIES OF PHOTOS LONG-TERM, UNLESS BEING USED FOR ADVERTISEMENT, SO NO ADDITIONAL COPIES OF PHOTOS CAN BE REQUESTED AFTER THE EVENT.

4.3 UNLESS OTHERWISE SPECIFICALLY AGREED HEREIN, THE PHOTOBOOTH OWNERS HAVE THE SOLE AND EXCLUSIVE RIGHT TO APPLY FOR COPYRIGHT PROTECTION FOR ALL OR ANY PART OF THIS ORDER.

**5. THE PHOTOGRAPHS**

5.1 UNLESS OTHERWISE SPECIFICALLY AGREED UPON HEREIN, THE PHOTOBOOTH OWNERS HAS THE RIGHT TO USE THE IMAGE MATERIALS FOR THIS ORDER AND REPRODUCTIONS THEREFROM FOR THE PURPOSES OF ADVERTISING, CREATING SAMPLES, DISPLAYING SAMPLES OF THE PHOTOBOOTH OWNERS PHOTOGRAPHIC WORK, ENTRY IN PHOTOGRAPHIC EXHIBITIONS AND OTHER PHOTOGRAPHIC CONTESTS, EDITORIAL OR ART DISPLAYS, DIGITAL SCANNING, INTERNET DISPLAY AND GENERAL DISPLAY FOR THE STUDIO.

**6. LIABILITY OF MJ'S PHOTOBOOTH**

6.1 IN THE EVENT THAT THIS ORDER CANNOT BE COMPLETED DUE TO AN ACT OF GOD; STRIKES OR OTHER LABOR DISTURBANCES; SEVERE WEATHER CONDITIONS OF ANY TYPE; RIOTS OR CIVIL DISTURBANCES;

ACTION OR REGULATION BY ANY LOCAL, STATE OR FEDERAL GOVERNMENT UNIT OR AGENCY; ANY EVENT CONSIDERED A "FORCE MAJEURE"; OR ANY OTHER EVENT OR ACT OUTSIDE THE CONTROL OF THE PHOTOBOOTH OWNERS, THE OWNER'S LIABILITY TO THE CUSTOMER SHALL BE LIMITED TO THE RETURN OF THE CUSTOMER'S DEPOSIT.

6.2 THE PHOTOBOOTH OWNERS SHALL NOT BE HELD RESPONSIBLE FOR THE UNLIKELY EVENT OF LOSS OR DAMAGE TO THE COPIES AND/OR DIGITAL FILES DUE TO ANY CAUSE STATED IN SECTION 6.1 OR FROM A CONTRACTED PHOTOGRAPHY LAB.

6.3 IN THE EVENT THAT THIS ORDER CANNOT BE COMPLETED DUE TO ANY CAUSE NOT DESCRIBED IN EITHER SECTION 6.1 AND 6.2 ABOVE, THE PHOTOBOOTH OWNER'S LIABILITY TO THE CUSTOMER SHALL BE LIMITED TO THE RETAIL VALUE OF THE CUSTOMER'S ORDER AS SET FORTH HEREIN.

7. **MISC**

7.1 THE STUDIO RESERVES THE RIGHT TO MAKE AN ADDITIONAL CHARGE TO THE CUSTOMER IF THE USAGE AND PURPOSE OF THIS ORDER IS OTHER THAN AS INDICATED HEREIN.

7.2 THIS ORDER IS BINDING UPON THE PARTIES, THEIR SUCCESSORS AND ASSIGNS, AND MAY ONLY BE ALTERED IN WRITING BY THE PARTIES.

NO REFUNDS OR EXCHANGES WILL BE PROVIDED IF ORDERS ARE NOT MADE WITHIN THIS YEAR PERIOD OUTLINED ABOVE, UNLESS IT IS AUTHORIZED BY THE STUDIO IN WRITING.**
